RE: HEALTHIER COLORADO HEALTH CARE POLICY SURVEY SUMMARY

Keating Research and Magellan Strategies are recognized by Democrats and Republicans alike as providing extremely accurate polling in Colorado. This is a summary of a survey commissioned by Healthier Colorado, a non-partisan, non-profit organization dedicated to raising the voices of Coloradans in the public policy process to improve the health of our state's residents.

This polling data is based on a 600n live telephone survey of likely 2018 General Election voters in the state of Colorado in which 60 percent of the interviews were conducted on cell-phones and 40 percent were conducted on a land line from September 18th to 20th, 2018. The survey results have a margin of error of +/- 4.00% at the 95 percent confidence level. The results are slightly weighted to reflect past voter turnout demographics in Colorado for a non-presidential election year.

Strong Voter Support for Healthier Colorado Policies and Proposals

The survey finds strong support among likely voters for Healthier Colorado's endorsed legislative policies and issue proposals, including:

- **The "Red Flag" law, which would allow a judge to take guns temporarily from someone who is determined to be a significant risk to themselves or others, based on evidence presented to the judge.** – 76% support, 34% strongly support
- **Increasing the purchase age of tobacco to 21 years** so it is the same as alcohol and marijuana. 76% support, 45% strongly support. And, **increasing the tax on e-cigarettes and nicotine vaping products so they are taxed at the same rate as cigarettes and other tobacco products.** – 73% support, 45% strongly support
- **Allowing people with limited or expensive health insurance options to purchase a health insurance plan from the state Medicaid program.** – 75% support, 34% strongly support
- **The Colorado Attorney General's recent lawsuit against a prescription opioid manufacturing company** for misleading health care providers and consumers about the risks of opioids. – 70% support, 28% strongly support

- The survey also included a question measuring voter opinion in the governor’s race. **Currently Jared Polis leads Walker Stapleton by seven points** (47% Polis – 40% Stapleton). Jared Polis’ lead is driven by his 18-point lead among unaffiliated voters (46% Polis – 28% Stapleton) and his 17 point lead among women voters (52% Polis – 35% Stapleton).

While voters debate the outcome of Colorado’s gubernatorial race, there is no debate that a strong majority of Colorado voters support the key health policies tested in this poll, including majorities of voters who support Walker Stapleton and majorities of voters who support Jared Polis.

Voter Opinion of the Red Flag Law

The overwhelming voter support for the proposed “Red Flag” law measured in this survey demonstrates the deep concerns Coloradans have about gun violence. Among all respondents, 76% support the Red Flag law and 34% strongly support it, only 17% of voters oppose the law. Even among Republican voters, who tend to be strong advocates for gun owner rights, 70% support the Red Flag law and only 22% oppose it. The responses to this question should send a strong signal to both candidates and incumbents that this law has the support of 3 out of 4 likely voters.

Voter Opinion of Changes to Cigarette and Tobacco Policies in Colorado

Majorities of voters on both sides of the aisle support changes to cigarette and tobacco policies in Colorado including increasing the age to purchase tobacco to 21 (76% support, 45% strongly support) and increasing the tax on “E” cigarettes and vaping products so they are taxed the same as cigarettes (73% support, 45% strongly support). Both policies have strong support among both Republicans and Democrats. To increase the age to 21 to buy tobacco products, support among Republicans is 80%, among Democrats 78%, and 69% among Unaffiliated voters. Regarding the policy to increase the tax on “E” cigarettes and vaping products, support is similar with 75% support among Republicans, 75% among Democrats and 69% among Unaffiliated voters.



Voter Opinion of Prescription Drug and Medication Pricing Transparency

Without question, Colorado voters universally agree that prescription drug companies should be more transparent on how they come up with prescription drug prices. Nine out of ten (88%) of likely voters agree - just under half strongly agree - that the public has the right to know the factors that go into the price of prescription drugs and medications to ensure fair and ethical business practices, including 83% of Republicans, 86% of Unaffiliated voters and 95% of Democrats.

Voter Opinion of Purchasing Health Insurance Plans from State Medicaid Program

Three in four likely voters support expanding Medicaid to allow people with limited or expensive health insurance options to purchase a health insurance plan from the state Medicaid program, while only 19% of voters oppose it. Jared Polis' voters are the most supportive of this Medicaid expansion with 87% support, while nearly two-thirds (64%) of Stapleton voters also support the policy.

Voter Opinion of CO Attorney General Lawsuit Against Opioid Manufacturing Company

When it comes to the opioid epidemic facing this country, 70% of voters support the Colorado Attorney General's recent lawsuit against a prescription drug manufacturing company that accuses that company of misleading health care providers and consumers about the risks, and the company profited off the epidemic that has led to 3,000 Colorado opioid deaths, while only 16% oppose the lawsuit. A majority of Polis supporters, 78%, and 65% of Stapleton voters support the lawsuit against the prescription drug manufacturer.

Colorado Governor Ballot Test

The survey finds Democratic Congressman Jared Polis currently leading Republican State Treasurer Walker Stapleton by 7 points, 47% to 40% respectively, and 11% of voters being undecided. Libertarian candidate Scott Helker has 1% support and the Unity Party of Colorado candidate Bill Hammons has no support. Among male voters, Walker Stapleton leads Jared Polis by 5 points, 47% to 42%; and among female voters, Jared Polis leads Walker Stapleton by 17 points, 52% to 35%. Among unaffiliated voters, Jared Polis leads by 18 points, 46% to 28%. Not surprisingly, the percentage of voters that are undecided is very low, only 5% among Democratic and Republican voters. However, among unaffiliated voters, 24% are undecided.

There are differences in candidate preference when looking at the data by income. Among households with an income less than \$75,000, Jared Polis leads Walker Stapleton by 16 points, 53% to 37%. Among households with incomes above \$75,000, Walker Stapleton leads by 5 points, 46% to 41%. Looking at the ballot test by education level, among voters with a four-year college degree or higher, the survey finds Jared Polis leading Walker Stapleton by 12 points, 49% to 37%. Among voters that do not have a college degree, Jared Polis leads by 3 points, 46% to 43%. The following table shows the Governor ballot test by voter subgroup.

The survey data is slightly weighted to reflect past voter turnout demographics for a non-presidential general election in Colorado.

Survey Methodology

This survey was conducted by live dialing both landline and cell phone sample. The sample used for this survey was randomly drawn from a state of Colorado voter file. The interviews were conducted on September 18th – 20th, 2018. Three attempts were made to interview each household in the sample. This survey has a margin of error of +/- 4.0% at the 95 percent confidence interval.
